In Finland, platforms are not discussed as a separate sphere needing special regulations. In Sweden, the most common issues in the debate are working conditions, employment security and collective agreements for platform companies. Unlike in other countries, in Denmark, in 2021, a collective agreement was reached with the food delivery platforms Just Eat, COOP FOOD and FØTEX together with a public campaign on fair transport, fair prices and fair working conditions. In the case of Norway, there is currently no consensus on whether online platform companies are to be considered employers in Norway.

In Germany, even if platform work has not received much attention, the public debate focuses more on data protection at the workplace. Various parties and trade unions have been calling for an employee data-protection law in addition to the requirements laid down in the GDPR.

All five countries have in common, that the lack of regulations has drastic consequences for platform workers, who work often under precarious conditions. This FES event by FES Future of Work and FES Nordics aims to address the issue of platform work, online platforms and platform workers in Nordic countries and Germany.

The event will be translated simultaneously into German and English.
